Relevance to CRISEPAC Objectives

On the official website of the Ministry, citizens may find information and guidelines regarding the steps that should be taken in case of earthquakes, landslide, forest fires, floods, storms, stormy winds, snowfall-frost, heatwave, volcanos, industrial accidents and chemical-biological-radiological-nuclear incidents. Information is also provided on daily fire risk forecast, including relevant maps. Like in the case of the CRISEPAC project, this tool aims to teach citizens how to protect themselves and people around them during natural hazards.
